Hello Grant,

I just got this email back from our press office - "We have looked into this and the Telegraph has a media license and are therefore allowed to print the map (even if it is derived from OS MasterMap). Obviously they would need to get approval for the release from the third party (map creator).

This is similar to the release of the new boundary information in Wales where newspapers had to use our media license to print the maps even though they were created by a third party.

I am conscious I may be aware soon so I am giving you a response that is a bit rushed.....

[Redacted - personal information]- Grant rang me to say that they create a national boundary dataset of greenbelt land which is collected from each LA and stitched together centrally. The Telegraph wan to publish this data. Do you have any advice for Grant?

Thank for the email, our local authority account managers feel that the creation of the greenbelt boundaries is probably captured against OS MasterMap Topo Layer (but it would be best to test that understanding with a local authority).

The OS does have a media licence and I am sure The Telegraph would have one from us but they would need to confirm this. It would be also god to understand what the Telegraph want the dataset for?

Secondly my thought is that as the LA are an IP holder so they may need to be asked their permission for publication too.

Thanks for your phone call - I have asked our legal team to review the situation and also informed our press office.

My initial thoughts are that the download is without any licence at all and published on a Google API which if derived from OS data would appear to go beyond the terms of the PSMA.

Under the PSMA any member may share data to a third party under the rights in the End User Licence as long as that activity supports core government business.

On the presumption that the Greenbelt data is derived from OS data - under what licence terms did DCLG supply this derived data?

I just confirmed that they had a media license - [Redacted - personal information] said that he wanted the shapefile "for display on interactive visualisations and/or as a research base" - however he did not say that he wanted to make files available for download.

I forgot that one of the questions we ask local authorities is what scale they have captured the Green Belt boundaries against - two of the options are OS Landline or OS Mastermap. I shall check what authorities have answered - if they've used Mastermap (or Landline?) then I think that it's clear that there's a licensing issue involved.

In your investigations with how the data was created do you have an understanding of how the local authorities themselves view the download - are they happy with the situation? Obviously they have an IP interest too.

The advice that OS will give you will partially be predicted on the results of your investigations as to whether the data is derived from OS data in the first place, and the view of the situation by the LA's, so a quick response will be appreciated.

In 2008-09, which is when the initial data collection was undertaken (and which is when most authorities' data will date from as most have not updated their Green Belt boundaries since) 57 out of 183 authorities used Mastermap and 50 used OS Landline. In subsequent years a majority of other authorities who updated their Green Belts used either Landline or Mastermap as a base.

As for what local authorities think we don't have the time to survey them individually. But [Redacted - personal information]'s email - attached below - makes it clear that there are three different parties with an IPR stake - DCLG, local authorities and Ordnance Survey.

The more I think on the situation the more I think that we should get the Telegraph to pull the shapefile, and perhaps the interactive map, even if only temporarily until proper licensing can be issued. What is Ordnance Survey's take on this?

Hello,

I would appreciate some information about licensing and re-use of the Green Belt for England spatial dataset that DCLG made available to the public in November via this article published on the Telegraph website:

Interactive map: England's green belt (Telegraph, 28/11/2013)

The Telegraph article says that DCLG "released the data for the 2011 green belt to the Telegraph, and it is being made available here to view, explore, share and download", and includes a download link for the dataset in a 29 MB zip file.

The same data has subsequently been made available for download from other websites such as the London Datastore and ShareGeo Open, and has been implemented as a layer on the RTPI's Map for England. However I note the dataset does not seem to be available for download directly from either DCLG's Open Data Communities website or from Data.gov.uk.

My questions are as follows:

1. Is this Green Belt for England spatial dataset available for re-use

under an open data licence, e.g. the Open Government Licence (OGL)? If not, what are the available licensing terms for re-use of this data?

2. If this dataset may be re-used under licence, what is the correct attribution statement? In other words, does the dataset contain any third-party intellectual property? I assume that at minimum the dataset will contain some Ordnance Survey derived data.

Hello [Redacted - personal information],

I had a meeting with Grant and [Redacted - personal information] before Christmas - the OS position remains that the release of this data is unlicensed, it should have been accompanied by a Public Sector Mapping Agreement (PSMA) End User Licence (EUL) stating the purpose of use by the Telegraph- this purpose of use would need to be linked back to DCLG's government business.

However - OS have taken a lenient approach to this situation - the PSMA has an exemption process allowing derived data to be treated as equivalent to the open data licence - in this case regularising what has already happened....

The open data terms would require an OS copyright acknowledgment.

I have had a meeting with [Redacted - personal information] and licensing colleagues - it is highly likely that if an exemption request is made by DCLG for this greenbelt data then OS would grant that exemption.

The complication is that there is additional IP in the dataset (ONS and Local Authorities). I have been in contact with ONS and they are happy with the data being made available as equivalent to open data under the exemption process.

My understanding is that DCLG would work with [Redacted - personal information] of LGA to get approval from the relevant LA's to make the exemption request to OS.

To date no exemption request has been received.
