Thank you for your response to my information request.

I note that you have not responded to my request for permission to re-use the disclosed information under the terms of the Open Government Licence, but that your cover email includes the following:

**"Re Use of Public Sector Information**

"Where Birmingham City Council is the copyright holder of any information that may be released, re-use for personal, educational or non-commercial purposes is permitted without further reference to the City Council. Where the re-use is for other purposes, such as commercial re-use, the applicant should notify the City Council in writing to seek approval or agree terms for re-use"

I have already made such a notification in my original request email of 10 December 2024, as follows:

**"Re-use request**

"I further request, in accordance with regulation 6 of the Re-use of Public Sector Information Regulations 2015, permission to re-use all information provided in response to the above access to information request for the purpose of combining that information with data from existing open public datasets and making the outputs available to others in a re-usable electronic form under an open licence. I request that Birmingham City Council grants permission to re-use the information for this purpose either without restriction or under the terms of the Open Government Licence v3 (#) or an equally permissive licence. Given my intended use, any more restrictive licensing terms would be likely to "unnecessarily restrict" the way in which the information can be re-used, contrary to RoPSIR regulation 12.

"If any third party owns intellectual property rights in any of the above requested information, which the Council is not authorised to license as requested, please specify the relevant information and the name of the third party.

"Further information request

"If Birmingham City Council is unable to disclose any of the above requested information, or is unable to grant permission to re-use any of the information as requested, please also disclose any information that the Council holds explaining those restrictions or barriers, including any relevant contract or agreement to which the Council is a party or under which the Council is bound."

I trust the Council will respond to my re-use request within the statutory timescale i.e. by 13 January 2025. Thank you.
